
Mounting Instructions:

- Pulling Head preparation (see TS-H84B-568 for details on the pulling head):
 - o Remove 652-050 (Sleeve Adaptor)
 - Remove 652-049 (Drawbar Adaptor) and replace with 744-802 (item 2)
- Mounting on the Riveter (see TM-G84-LS for riveter breakdown):
 - o Remove P85 and 744-145 (socket head screw and PH Stop)
 - Thread the Sleeve Adaptor (item 1) onto the riveter until tightened, then orient it so one of the driving flats is oriented with the threaded hole from which P85 was removed from;
 - Thread P85 and 744-145 back in to lock the adaptor in place;
 - Thread the Drawbolt Adaptor (item 2) assembly into the riveter piston; use the 1/4" hex socket at the back end of the adaptor to drive it in and tighten it securely.

CAUTION:

- When used with pull through pulling heads, high velocity stems will be ejected at the back of the riveter.
 It is recommended to use the adaptor and stem deflector shown below to prevent injuries.
- These components are not included in this kit; they work with any of the Cherry™ adaptor kits available for this riveter
