


It will install 1/8", 5/32" and 3/16" bulb & wiredraw CherryMax® rivets in all materials head styles and grip lengths.

INSTALLING H846A-456 PULLING HEAD ON RIVETER



- 1. Place jaws (F) inside of the collet (E). Place bumper (H) and spring (I) over the jaw follower (G) and put this assembly inside collet against jaws.
- 2. Screw this assembly onto end of head piston and tighten securely using wrenches on flats provided. Use of Loctive #242 is recommended.
- 3. Thread outer sleeve (c) which contains jam nut (D) snugly into end of head cylinder. Tighten jam nut (D) securely.
- 4. Refer to parts list below for ordering replacement parts.
